Section 6 - Accidental Release Measures

Emergency Procedures

Increase ventilation. Evacuate all unprotected personnel. Wear sufficient respiratory protection and full protective clothing to prevent exposure. Avoid breathing dust/mist. Sweep up material avoiding dust generation or dampen spilled material with water to avoid airborne dust, then transfer material to a suitable container. Wash surfaces well with soap and water. Do not flush into surface water or sanitary sewer system. Seal all wastes in labelled containers for subsequent recycling or disposal. Dispose of waste according to the applicable local and national regulations. If contamination of sewers or waterways occurs inform the local water and waste management authorities in accordance with local regulations.

Section 7 - Handling and Storage

Precautions for Safe Handling

Avoid inhalation of mists/dusts, and skin or eye contact. Do not get this material on clothing. Do not breathe dusts or mists. Use only in a well ventilated area. Keep containers sealed when not in use. Prevent the build up of dust in the work atmosphere. During mixing or sanding of product minimise the creation of dust as much as possible. Maintain high standards of personal hygiene i.e. washing hands prior to eating, drinking, smoking or using toilet facilities. Do not eat, drink or smoke when using this product. Persons with a history of skin sensitisation problems or asthma, allergies, chronic or recurrent respiratory disease should not be employed in any process in which this mixture is being used.

Conditions for safe storage, including any incompatibilities

Store in a cool, dry, well-ventilated area, out of direct sunlight and moisture. Store in suitable, labelled containers. Keep containers tightly closed. Store away from incompatible materials. Ensure that storage conditions comply with applicable local and national regulations.
